Please read entire application before completing

A **\$5.00 fee** will be collected for each quilt exhibited for the Franklin County Homemakers and Quilt Batts community projects fund. The \$5.00 will be collected at the time of entry. Please make checks payable to Franklin County Quilt Show. Exhibitor will receive **one admission ticket** for personal use to visit the quilt show once.

Items for the Challenge Category, along with application, must be turned in to the Franklin County Extension Office, Government Center, 1010 Franklin Avenue, Room 214, Brookville, IN 47012 by **May 9, 2018**. This will allow time for judging.

1st, 2nd and 3rd place monetary awards will be made in the Challenge category.

For this Challenge, a quilt, table topper, purse, wearable item or any other quilted item may be entered if it follows the color guide lines. The majority of the item should be constructed of black and white prints or solids. The accent color may be one fabric or multiple fabrics of the same color.

Acknowledgement of pattern designer and of quilter (if not done by exhibitor) should be included in quilt story if this information is known.

Quilted items can be **picked up on Saturday, May 19 from 6:00 until 7:00 p.m.** Please make other arrangements if this time is not possible.

The committee reserves the right to refuse any quilt or item that is deemed not appropriate for this quilt show.

All reasonable care will be taken to make sure that the condition of the quilted items are maintained, however neither the committee nor the Franklin County Extension Homemakers or Quilt Batts can be held responsible for damages that could occur.
